Dates of Show: November 9, 10, 2012

Location: Veda Sheid Community Development Center, ASUMH, Mountain Home, Arkansas

Application Deadline: June 30, 2012

This juried show is open to all artisans of hand crafted fine art of all mediums.

- ◆ Only original arts and crafts are accepted. (2-D artist: reproduction prints from artist's original are allowed along with originals)
- ◆ Each booth display must consist of only the artist's work and must be in the medium they submitted on application and accepted by our Standards Committee. All booths will be reviewed during the show. Ozark Regional Arts Council reserves the right to request artist remove work that does not comply with show rules.
- ◆ Please complete and submit attached application with deposit or fee paid in full, three photographs of your work plus one photograph of booth display. Include name and medium on back of photograph. If submitting by CD, images must be 300 dpi jpeg format and must include artist name and medium as part of file name (example: joessmithpottery1.jpeg, joessmithwatercolor2.jpeg etc) Please also submit a printed sheet describing the images submitted for both photographic and CD submittals.
- ◆ Minimum one half of booth fee deposit is required with applications being submitted prior to May 15, 2012. Fees must be paid in full by the June 30, 2012 deadline. Submittals After May 15, fee paid in full is required.
- ◆ Applications will be reviewed by our Standards Committee. If not accepted, deposit will be returned. If accepted, deposit is refundable as stated below.
- ◆ Booth Fees:

8 x 10 -	\$150.00	
10 x 10 -	\$175.00	10 x 10 corner - \$225.00
10 x 20-	\$325.00	10 x 10 end - \$425.00
- ◆ \$25.00 late fee applies to all applications submitted after the June 30, 2012 deadline.
- ◆ Cancellation prior to July 31, 2012 will be refunded less \$50.00

Cancellation after September 30, 2011 will be refunded one half of total booth cost.
Cancellation after October 15, 2012 will not be refunded

- ◆ Artist must be in attendance at their booth during the show.
- ◆ Convention Center Layout and booth assignment will be e-mailed to the artist after the June 30, 2012 application deadline as soon as it becomes available.
- ◆ A guide for the layout of the show will be printed as handouts at the show and will be in local area newspapers the week of the show. Invitational postcards will be available to each artist to mail to their patrons.
